## **62nd ANNUAL GENERAL MEETING**

Meeting was called to order at 7:01 PM on April 8<sup>th</sup>, 2024. By ZOOM teleconference.

#### 4. Reports

#### a. Report from the President

Part 1 (written prior to the BC Combined Championship (BCMCC))

It has been a very busy and productive Spring, and the results are positive. For example, by using Vernon and Armstrong for our first official 5 Event BC Combined Championship, the plan of the BC Interior Masters Curling Association (BCIMCA) has come together very well. The BCIMCA with the use of filler teams is showing a full slate. The competition will now be hosting 32 (4 person teams) and 16 (2 person teams). This will be the largest Award Banquet ever held. In fact, I suspect it will be largest provincial award banquet in BC history.

I am extremely pleased at the number of directors that have committed to Vernon and we can expect an interesting PCMCA-BCIMCA Joint Meeting to be held the evening of March 25th. The agenda is set to discuss Amalgamation,

Name Change, and Sponsorship. As all of you are aware Amalgamation had made some in-roads during 2019, however due to Covid-19's appearance in March 2020, all of us left the BCMCC at Penticton, not knowing if, or when, we would ever curl again. Between March 2020 and March 2024 costs have risen and sponsors have diminished. Coupled with challenges of acquiring ice, committees are constantly expressing concerns re playdowns and future venues for the PCMCA/BCIMCA competition. We anticipate cost increases in ice, rental, league fees, Curl BC and Curl Canada dues. It is probably timely that the Board voted to increase the PCMCA dues from \$5 to \$8 subject to our members' approval. This will assist both our PCMCA Zone Boards and our overall PCMCA Board in their planning and budgeting.

Our overall PCMCA Board has grown and there is presently a wealth of experience. This year it added a Director of Communications, and for the 2024-25 season it will be including a new role --- Director of Competitions, which will be taken on by the Vice President. The goal here would be to have one individual confirming policy and procedures to host Playdowns and Provincials. That will assure uniformity in that no changes will take place without the approval of the Director of Competitions.

Overall, it has been a great year with a 20% increase in membership and most of that has been an increase in women joining the PCMCA. Presently the PCMCA is very close to its pre-Covid numbers. The demographics are showing an aging membership. For example, this year 52% of the membership is in the 70-79 age group. Based on this information my suggestion is that we should immediately create an 80+ category. In speaking to some of our members there is an abundance of positive feedback. Many of the 80+ members are losing interest in competing against the 60+ teams on the provincial scene. My request to the Board is that an 80+ Event be added to the 2025 Provincials in Langley/Cloverdale. This venue offers us 12 sheets which can certainly include it as a 6th category. It would be offered as an Open event, including women and men and would include stick and wheelchair curlers.

Part 2 (written after the BCMCC)

After viewing the phenomenal success of the 16 team Stick Curling championship in Vernon/Armstrong, it is obvious that the association's expansion to more members was the right decision. This year's BCMCC had a record 48 team championship hosting the largest event any of us have ever witnessed. The event resulted in a full slate of entries and was attended by largest ever contingent of PCMCA directors. Present were Zone 1 Mike Angrove, Zone 2 Claude Latulippe, Zone 3 Nancy Stagg and Clyde Mitchell, and Zone 4 Jack Holden. From the PCMCA Executive were Treasurer Cheryl Eason, Communications Director Wayne Saito and me. Also, we were fortunate to have the presence of our Webmaster Mike Toller who was available to help the volunteers post live results to the website.

This completes my 6th season serving you as President. I have experienced the challenges of Covid and the reward of expansion. It has been a wild ride and except for Covid, there is little I would change. The pleasure of working with so many different directors, committees and clubs has been extraordinary. During this time some directors have retired, and some are new, however my opinion is that the board is presently bigger and better than ever.

A big "Thank You" to all the directors with whom I have had the pleasure of working over the last 11 years.

#### Draft 2023/24 PCMCA Financial Statements

  of Cashflows.
- Attachment #2 compares the draft actual year-end results to the approved budget for 2023/24.

#### Draft 2024/25 PCMCA Budget

- Attachment #3 provides the draft 2024/25 PCMCA budget
- The recommended version reflects member fees of \$8/per member (total = \$18,800) and a zone reimbursement of \$4/per member (total = \$9,400). The excess of expenses over revenue is estimated at \$2,900 (deficit).
- The status quo version would maintain member fees at \$5/per member (total = \$11,750) and a zone reimbursement of \$2/per member (total = \$4,700). The excess of expenses over revenue is estimated at \$5,250 (deficit).
- Both versions reflect a 3.5% increase in membership numbers from actual of 2,269 in 2023/24 to 2,350 in 2024/25.

## c. **BC Masters Combined Championship Reports**

## 2024 (Vernon/Armstrong) submitted by Clyde Mitchell

The 2024 Combined Championship was held in Vernon and Armstrong Curling Clubs with a record 48 teams (160 curlers plus 5th team members) participating in 5 categories. The four-person events were held at Vernon and the 2-person Stick curling at the Armstrong Club.

The Combined was a success thanks to BCIMCA President, Bill Gawiuk, and his organizing committee. Due to the record number of participants, there were some organizational issues at the Vernon Club (the opening ceremony and the closing banquet) that will have to be considered for the 2025 event. The ice quality at the Vernon site was poorer than expected. The Stick Event held at Armstrong CC with both PCMCA and BCIMCA teams was also a great success thanks to the team of volunteers lead by Daryl Sears.

The BCMCC website, developed by Mike Toller, was also heavily used leading up to and during the Combined. Mike reports that the website was contacted from more than 1600 individual IP addresses and almost 7000 times between January 1 and March 30.

Overall, the teams representing the PCMCA zones curled well and brought home Combined trophies in three of the five events (70+ Men's (Zwarych), Women's

(Stagg), and Mixed (Keyes)). Additionally, Team Stagg (60+ Women), Team Angrove (60+Men), Team Zwarych (70+ Men), Team Holden (Mixed) and Team Schwartz (Stick) won the Association trophies. Congratulations to all these teams.

Organization for 2025 is already underway. The 2025 Combined Playdown will be held at the Langley and Cloverdale from March 24 to 28 with five full events as in 2024. A new category, 80+ four person curling, is under consideration as a demonstration event.

## 2025 (Langley/Cloverdale) reported by Bruce Lonsbery

Langley/Cloverdale has been confirmed.

Cloverdale is undergoing a complete renovation of its ice floor. All will be removed and replaced. If there is any unforeseen delay which caused Cloverdale to drop out, then Abbotsford has agreed to be on standby.

The clubs have offered an extremely favourable rate for ice. The cost is expected be about \$2,000 plus tax.

Langley and Cloverdale have very good accessibility for any wheelchair curlers who qualify for the BCMCC.

There will be an Open 80+ event, open to both men and women curlers. It will be a demonstration competition, featuring only competitors from the PCMCA.

The PCMCA will purchase winners' banners for the winning teams. The objective is for the winners' banners to be displayed at their home clubs, and tangentially to promote the PCMCA to curlers throughout coastal BC.

## d. **Zone Reports**

## Zone 1 (Lower Island) reported by M. Angrove/P. Malnarich

A good year at Victoria with membership staying close to the previous year. Esquimalt remained with similar numbers to last year. Playdowns saw Kerry Park

and Duncan entering both the 60+ and the 70+ men's for the first time in a number of years.

Currently the Monday senior men's league has 20 teams interested in the next season. However, the Tuesday and Friday leagues are not running at capacity.

## Zone 2 (Fraser Valley) reported by C. Latulippe

#### **FINANCE**

Don Cameron provided a Financial Report. Unfortunately, no revenue has yet been received from the PCMCA. Don reported that our operating account is now below \$300 but our Savings Account remains healthy at \$5,532.09. Bruce Lonsbery indicated work is being done by the PCMCA to ensure Clubs submit their PCMCA fees promptly. Masters Club Presidents are asked to encourage Club Managers to submit the PCMCA dues promptly. It was moved by Mike Bergerman and seconded by Gary Mitchell to approve the Financial Report.

## SERETARY/TREASURER

Discussion was held on the merits of this option for covering the Secretary/Treasurer position. It was stated that considerable difficulty trying to get someone to do the job had been the experience of the FVMCA. Changing the person in the position each year was cumbersome and may require time-consuming banking changes. However, several expressed concerns about setting the precedent of a paid position when everyone else is a volunteer. Concern was expressed about the President being in one Club and the Secretary-Treasurer in another. Others said we should at least give it a try and see if it works effectively. It was moved by Sid Clarke and seconded by Mike Bergerman to commit to Don Cameron as Secretary-Treasurer for three years with an annual honourarium of \$750 (Carried)

#### SPIEL FROM Z2 CLUBS

Claude Latulippe commented on a Chilliwack bonspiel that was enjoyed by participants. The bonspiel had two divisions – A for out-of-town teams and a second draw, B, for mixed, ladies and farmers' Chilliwack teams. The bonspiel seemed to accommodate everyone and was successful financially. However, although the overwhelming majority of the participants were PCMCA members,

some were not. Considerable discussion occurred on this point as the rules for FVMCA bonspiels insist that participants must be PCMCA members. Bonspiel structure was discussed at various points throughout the meeting including during the President's Reports. It was generally concluded that individual Clubs are responsible for how they operate their bonspiels and experimenting with different options in organization and structure should be encouraged. Everyone, at one point or another, supported the importance of keeping bonspiel participants numbers healthy.

## **ZONE 2 PLAYOFFS/PLAYDOWNS**


Bruce Lonsbery commented on the order for Zone playoffs designed to maximize participation. He recommended the order be as follows: 1. Men's 60+ and Men's 70+ 2. Ladies 3. Mixed 4. Stick He suggested the Men's and Ladies can be scheduled close together with two weeks between each event. This would allow unsuccessful Men or Ladies to move to Mixed or Stick playdowns. The combined, being scheduled for March 24-28 in 2025, means starting playdowns in late January. Bruce also mentioned that to accommodate the rising number of over 80 curlers, the PCMCA is considering introducing a Men's 80+ demonstration competition. This idea received positive comment from the directors.

## Zone 3 (Metro Vancouver) reported by N. Staga

- Formation of a Bonspiel/Playdown Committee. This committee played an integral part in standardizing the updated playdown rules.
- Renewed interest in our Zone's bonspiels and playdowns (which in part, can be attributed to the Bonspiel/Playdown Committee.) Leagues within Zone 3 hosted 8 bonspiels this year while two planned spiels were canceled. (There are plans already underway to have both these events back on the calendar next season.) It was great to hear reports that included phrases such as 'well-attended' and 'fun-was-had-by all'. Also, Zone 3 hosted playdowns in all Combined categories and sent participants in all categories (and more) to the Vernon.
- \* Three Zone 3 teams won their Combined categories: Mixed Team Keyes, 70+ Men's Team Zwarych, Women's Team Stagg. Arrangements are being made for banners for these winners.
- More exposure for the PCMCA leagues was attained when the Royal City

Curling Club agreed to host a PCMCA league page within their website. This page includes information on the three leagues that play out of RCCC and includes a link to the PCMCA main website.

- The PCMCA logo was distributed to all league contacts. More leagues now include the PCMCA logo on their posted drawsheets increasing PCMCA exposure to all curlers at the various clubs.
- Work has started on training/learning sessions to be held in September.
- Earlier deadline for Playdown entries was introduced. This, combined with a required deposit, made the planning for ice time, draws and other paperwork easier (from a time perspective) for the organizers.
- An eTransfer system was piloted for Playdown deposits and worked well. For the coming year, there will be a continued focus on increasing the profile of the PCMCA within our Zone 3 area, to make the PCMCA relevant to more members and to attract new members.
- First steps were taken to increase the flow of information between clubs and members with the distribution of two Zone newsletters (November & April).



## Zone 4 (North Island) reported by J. Holden

By all accounts, it was an excellent season for senior curling in all four of the zone's curling clubs; Nanaimo, Parksville, Qualicum and Comox Valley. Thanks to Cheryl Eason's statistical report, we know that we had 740 PCMCA members, the highest number of any of the four zones. There were 428 men and 312 women. Demographics show that the largest age group for men is 70 to 80 (45%) while for women it's 60 to 69 (53%).

The Nanaimo Curling Club hosted the zone playdowns in February. All categories had entries and sent teams to the Combined in Vernon. The mixed team of Jack Holden, Mickey Colburn, Dennis Colburn and Mary Holden from the Comox Valley CC were able to bring home the PCMCA Mixed Shield.

And finally, on behalf of all current and past Zone 4 PCMCA members, we wish to thank Brian Scorer and Cliff King for their many years of outstanding work as our Zone 4 PCMCA Directors, club representatives and overall administrators extraordinaire. They are now enjoying a well-deserved retirement. The new Directors are Jack Holden from the Comox Valley CC and Rick Dunn from the Parksville CC.












#### New Business

President Woytowich outlined the purpose of a new Director of Competitions in his President's Report in Item 4(a) above. The role will be included in the functions of the position of Vice President. As such, no motion was needed to create a new executive position.

#### 6. **Elections**

President Woytowich outlined a temporary one-year organizational chart for the PCMCA executive. The existing structure of the PCMCA Board consists of Past President, President, Vice-President, Treasurer, Secretary, Communications Director and two Directors from each of the four zones. The total is 14 Board members. The purpose of the temporary plan is to provide a succession plan that accommodates the transition needs resulting from his need to retire from the Presidency and for the incumbent Vice President to delay moving into the Presidency for personal reasons. In this plan, Lawrence Woytowich would accept a one-year term, continuing as President. Current, Vice President Bruce Lonsbery would continue in a one-year extension of his term, while he would be joined by a second Vice President, Clyde Mitchell who would be starting a usual two-year term. The overall size of the Executive remains unchanged as both VPs are also doubling as Zone Directors in Zones 2 and 3.
